






















<a href="#">H.R. 7</a>	1/9/23	Referred to the Committee on Energy and Commerce	Value of Human Life	Specifically, the bill prohibits the use of federal funds for abortions or for health coverage that includes abortions.	
<a href="#">H.R. 26</a>	1/9/23	Passed the House. Received in the Senate	Value of Human Life	This bill establishes requirements for the degree of care a health care practitioner must provide in the case of a child born alive following an abortion or attempted abortion.	
<a href="#">H.R. 73</a>	1/9/23	Referred to the House Committee on Energy and Commerce.	Value of Human Life	This bill prohibits federal funding of the Reproductive Healthcare Access Task Force.

Value of Human Life	To amend title V of the Social Security Act to require assurances that certain family planning service projects and programs will provide pamphlets containing the contact information of adoption centers.

Value of Human Life	To nullify the modifications made by the Food and Drug Administration in January 2023 to the risk evaluation and mitigation strategy for the abortion pill mifepristone, and for other purposes.	
<a href="#">H.R. 384</a>	1/17/23	Referred to the House Committee on Energy and	Value of Human Life	To prohibit the use or declaration of a public health emergency with respect to abortion, and for other purposes.

Value of Human Life	To amend the Public Health Service Act to prohibit the Secretary of Health and Human Services from conducting or supporting any research involving human fetal tissue that is obtained pursuant to an induced abortion, and for other purposes.
